ORDER

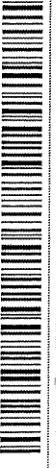
1. As per the notification read (1) above, university invited applications for continuation of provisional affiliation for the academic year 2023-24, from colleges for the courses affiliated to the university. In response to the same, the Principal Ahalia Ayurveda Medical College, Palakkad vide paper read (2) above has submitted their application with necessary documents and remitted required fee.

2. As per clause II (4) in Ordinance No. 21306/AC1/GEN A2/2020/KUHS dated 17/06/2021, inspection was not conducted at the college with regard to granting of continuation of provisional affiliation for 2023-24, since the first batch of BAMS course has been passed out.

3. The matter of granting Continuation of Affiliation to Ahalia Ayurveda Medical College, Palakkad without conducting inspection was placed in the 72 nd meeting of the Governing Council dated 27.12.2022 and vide decision read (3) above, Governing Council resolved to grant continuation of provisional affiliation to the college for conducting the UG(BAMS) courses with annual intake of 60 seats for the academic year 2023-24 subject to the receipt of Letter of Permission from the Ministry of AYUSH .

4. The Medical Assessment and Rating Board for Indian System of Medicine, NCISM, Ministry of AYUSH, Govt. of India vide paper (4) above has reduced 10% seats as per their seat reduction policy for the failure of the college in maintaining minimum essential standards and granted Conditional Permission to Ahalia Ayurveda Medical College, Palakkad for intake of BAMS.

5. In this circumstances, orders are issued granting Continuation of Provisional Affiliation to Ahalia Ayurveda Medical College, Palakkad for conducting BAMS course with **54 seats** for the academic year 2023-24, subject to the following conditions

1. The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting permission to the college for conducting UG course in Ayurveda during 2023-24 vide letter read (4) above.
2. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
3. In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
4. Affiliation granted is strictly provisional and only for the academic year 2023-24. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
5. The College should remit annual administration fee fixed for UG/PG course for the academic year 2023-24.
6. Admission to the next academic year shall be made only after obtaining prior permission from the University.
